Child Safety Learning Collaborative (CSLC)



The aim of the CSLC is to **reduce fatal and serious injuries** among infants, children, and youth ages 0-19 by supporting **collaborative improvement** among states and jurisdictional level Title V agencies.

We do this through:

- Using a shared “all teach/all learn” model of collaborative learning
- Supporting states to use a quality improvement approach
- Addressing shared strategies to increase the potential for collective impact across CSLC states.

Application: Eligibility

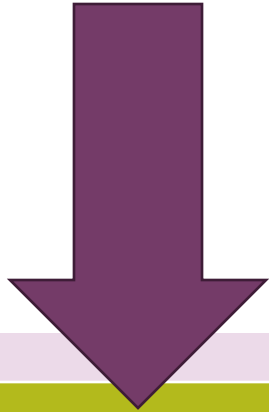
- This opportunity is for all state/jurisdiction Title V agencies

- Aligns with current MCHB National Performance Measures, Title V MCH goals, and identified state strategies
- Organized across the social-ecological model
- Process and proxy measures to help collect and measure real-time improvements



Topic Teams

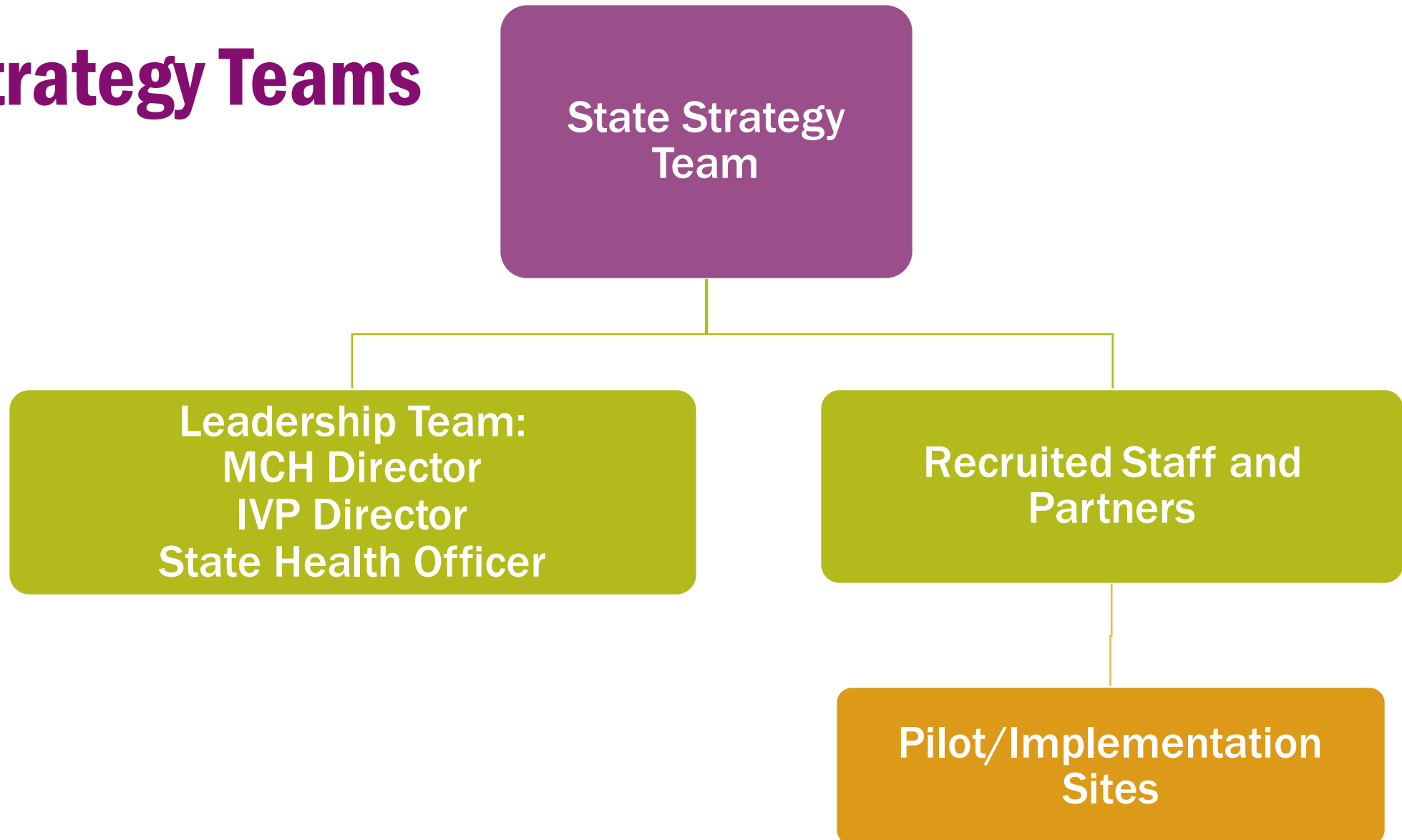
- Topic team for each of the select child safety topic areas
- Comprised of all state and jurisdiction strategy teams
- Work within the topic change package for collaborative outcomes
- Led by CSLC staff member
- Provides opportunity for all teach/all learn approach

Participation Commitments

- Identify appropriate partners and create a Strategy Team
- Select and implement 1-3 evidence-driven strategies from the topic change package
- Utilize quality improvement methods
- Access, collect, and report real-time monthly data to contribute to collective impact measurement
- Engage in monthly online meetings and periodic learning sessions (mostly virtual)



Learning Collaborative Activities



New Member Orientation Webinar: October 24th or 26th (choose one)

- An overview of the Learning Collaborative change packages
- Guidance for identifying common strategies and measures
- Technical assistance on strategy team development and strategic planning



Initial Consultations Scheduled Nov - Dec

- Online interview with each state's Strategy Team lead, Data Manager and MCH and/or IVP leader
- Create team profile to share on CSLC member-only web portal with state Strategy Team interests, strengths and needs



Learning Sessions - Up to Three Per Cohort

- Meeting of all Topic Teams
- Content includes action planning and accelerating learning
- May include pre-work, such as opportunity to present on successes and lessons learned
- **First Session is hybrid and held in Waltham MA on Feb 1 & 2, 2024**
****CSN will cover travel costs for 1-2 members of each team to attend this hybrid event*



Topic Calls: Every Other Month

- Virtual meetings of all states/jurisdictions working on a specific child safety topic
- Takes place every other month between Learning Sessions
- Topic calls take an *all teach, all learn* approach. Active participation is expected from each state/jurisdiction strategy team



State Technical Assistance Webinars (STAW)

- Hosted on months when topic calls not held
- Webinars for **all** state/jurisdiction health departments to build child safety and quality improvement capacity
- Opportunity for states/jurisdictions to build capacity necessary to join a future CSLC cohort
- Delve into cross cutting themes on common populations, settings, and issues in child safety
- *CSLC participants are expected to attend*



Monthly Reports

- Process measures to monitor progress of spreading child safety strategies
- Qualitative data including lessons learned, barriers, and success
- Team self-assessment and tailored feedback from CSLC topic lead
